FIRST THING'S FIRST

Once you're <u>ordained</u> , you'll need to review marriage laws and <u>registration</u> <u>policies</u> in the state where you'll be performing marriage.
Consider ordering <u>Asked to Officiate</u> (our AMM-exclusive officiant guidebook) to get fully acquainted with your role and obligations as a wedding officiant.



AT LEAST 9 MONTHS BEFORE THE WEDDING

(OR AS SOON AS THE DATE IS SET)

Meet with the	couple	and	begin	your	discussion	about their	ceremony
expectations.							

→ Be sure to ask questions, <u>take detailed notes</u>, and gather as much information about the wedding and the couple as possible. This will help shape the ceremony and hone in on the details that will make it unique to them.

3-9 MONTHS BEFORE THE WEDDING

Order your credentials or registration materials. Remember, regardless of where you live, you'll want to order your credentials for the state (and/or county) where the wedding ceremony will be taking place.

CURRENT SHIPPING OPTIONS

- USPS Media Mail (Up to 3 Weeks + Tracking) Free
- USPS First Class Mail (3-5 Business Days + Tracking) \$4.50
- USPS Priority Mail (2-5 Business Days + Tracking) \$8.00
- USPS Express Mail (1-2 Business Days + Tracking) \$25.00
- USPS International (7-21 Days + Tracking) \$35.00
 - → If you're performing marriage in a state with registration requirements, allow enough time for your documents to arrive in the mail, and then additional time to submit them to your county clerk's office without worrying about rushing. If you're concerned about receiving your materials quickly, we recommend selecting Priority or Express Mail to ensure a timely arrival.

- If you order your registration materials too early (more than a year in advance), the county clerk's office will likely request a newer set of documents - which means you'll have to place a new order for updated materials, and potentially delay your registration. However, if you order too late (less than a month before you need them), you risk not being able to register in time. Stick to our timeline and don't get caught in a bind!

Keep all of your credentials, important documents, notes, and ceremony scripts organized and in one place. (Need help? Check out our Royal Officiant Folio!)



3-6 MONTHS BEFORE THE WEDDING

If you haven't yet begun, it's time to start drafting the ceremony script.
Visit the <u>Wedding Training</u> section of our site to review the ceremony basics.
Check in with the couple as needed to ensure you're all still on the same page (quite literally) with the desired ceremony components and expectations.
If you're feeling a little overwhelmed and want a detailed crash-course on officiating, consult <u>Asked to Officiate</u> for step-by-step guidance on how to craft and deliver a thoughtful, memorable wedding ceremony with confidence!
If you plan on gifting the couple with a <u>commemorative marriage certificate</u> , place your order <i>now</i> .

3-4 WEEKS BEFORE THE WEDDING

Finalize the ceremony with the couple. Go over timing, any special details (like ceremony readings from other family or friends), and get their approval of the finished script you have created.

	Confirm that the couple already has or will pick up their marriage license.
	Practice, practice the ceremony!

DA'	Y BEFORE THE WEDDING
	Attend the wedding rehearsal and practice the entire ceremony.
	→ Typically, this is when couples hold their wedding ceremony rehearsal. It's not always possible to be present, but it's strongly recommended. Some professional officiants will do the rehearsal for an additional fee. Most absolutely insist on attending the rehearsal, and simply include the fee in their pricing. If you're officiating for friends or family, make sure they understand how important the rehearsal is.
	Carefully review the information on the marriage license to ensure that the details are correct.
	→ Marriage license return policies vary across the country. Some important things to note are:
	 How soon the completed license must be returned after performing the ceremony Where it must be returned to Who is responsible for returning it (the couple or the officiant) Whether it must be returned in-person or by mail
	Check the weather forecast to plan ahead for attire changes, or potential logistical issues (traffic, sound system if outdoors, etc).
DA'	Y OF THE WEDDING
	Bring several copies of the ceremony script - including a digital copy (emailed to yourself or saved on a mobile device) <i>and</i> printed paper copies.
	Perform the ceremony!
	Complete the marriage license.

	Celebrate and take photos with the couple to commemorate a job well done!
AFT	ER THE WEDDING
	Return and file the completed marriage license according to the instructions provided. If it's the couple's responsibility, make sure they follow through.
	Upload your photos and ceremony script to the <u>AMM Wedding Wall</u> !
